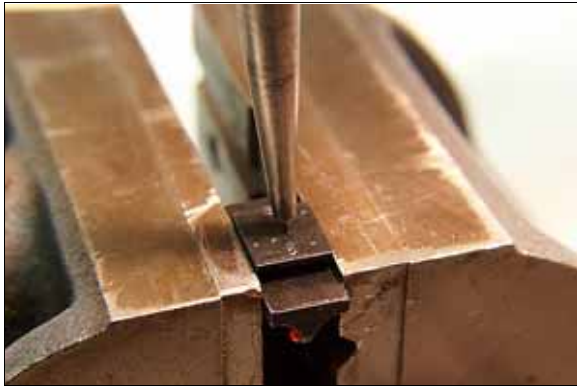

1. Drift out the factory front sight.



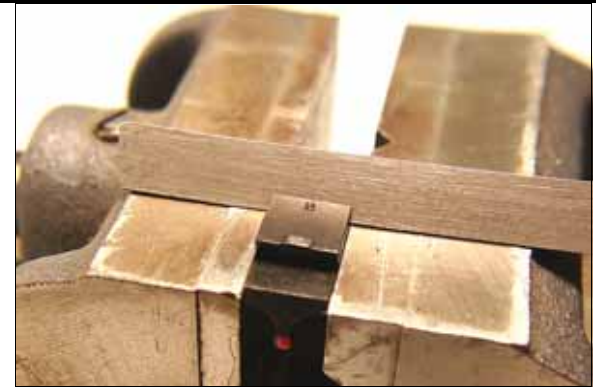
2. Check the fit -- correct when the sight can be pushed in about half way by finger pressure only.



3. If the fit is too **loose**, place the sight in a non-marring spanning fixture (no pressure on the blade -- only on the perimeter) and use a sharp punch to stipple the sight bottom until the fit is sufficiently tight.



4. If the fit is too **tight**, first clean out the dovetail with a 60 degree file. Do **NOT** remove material.



5. If the fit is still too tight, place the the sight in a non-marring spanning fixture, and dress about .002" off the bottom of the sight **only**. With a sharp file, this should only take a few strokes. Keep the file level and remove the same amount of material across the entire base of the sight.



6 Once the fit is correct, drift the sight in until it is centered on the rifle. Use a non-marring drift tool.



Installation Is Complete.

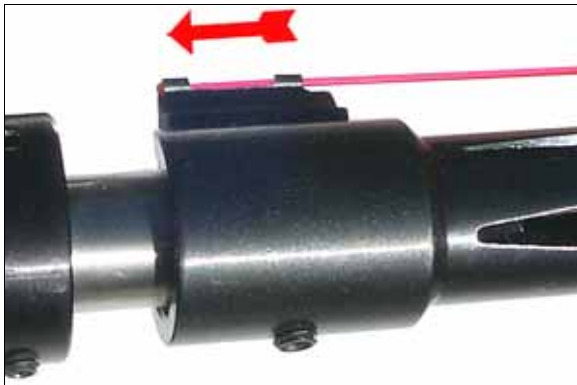
ROD REPLACEMENT



1. First, cut the old rod. Take care not to mar the sight blade.



2. Next, remove the sections in opposite directions.



3 Insert a new section of rod in the color of choice. Allow about .100" of rod to protrude beyond the front rod support frame. The longer the protrusion, the larger the resulting "dot".



4. Touch the front of the rod for just a moment to allow a bead to form, no longer.



5. Trim off the rear of the rod about .100" past the end of the rear rod support frame.
